  manufacturers, the shipping was 14-16 weeks opposed to 2-3 days. The cost difference was
  minimal with a total of \$10,000.00 for all 3 valves. Cost approved by the Board.
- Issues with the new blower unit were discussed and measures to resolve in moving forward.
   We hope to get the pontoon on the lagoon soon, weather permitting.
- Staff have been delegated specific tasks, and they are in charge of on a regular basis.
- Jerry let the Board know that an employee's gift card from Thanksgiving and Christmas had been compromised. He went ahead and authorized for both cards to be replaced.
